Your Privacy is important to us

This American Health and Life Insurance Company and Triton Insurance Company privacy policy ("Privacy Policy") describes our practices regarding information collected about you during visits to the Site.

"Site" means (www.promotionalbenefits.com) and includes any and all interactive features, widgets, plugins, applications, content, downloads and/or other services maintained by American Health and Life Insurance Company and Triton Insurance Company.

The terms "we," "us," "our," or "Companies," as used on this Site, mean American Health and Life Insurance Company and Triton Insurance Company. The terms "you" or "your" mean and include you as an individual person and, if you are an employee or representative of another person or entity, such person or entity.

In addition, please review the Terms of Use, which governs your use of the Site. By continuing to use the Site, you agree to this Privacy Policy and the Terms of Use and our collection, use, disclosure and storage of your information as described by this Privacy Policy. This Privacy Policy does not apply to:

- Data we receive from third parties, unless we combine such data with Personal Information (defined below) that we have ourselves collected under this Privacy Policy;
- Our data collection activities offline or otherwise outside of our Site (unless otherwise stated below); or
- The data practices of third parties that may interact with our Site, such as social media sites and websites where we advertise.

Nonpersonal Information

We and our third-party service providers may use a variety of tracking technologies that automatically (or passively) store or collect certain nonpersonal information whenever you visit or interact with the Site ("Usage Information"). This Usage Information may be stored or accessed using a variety of technologies that may be downloaded to your personal computer, browser, laptop, tablet, mobile phone or other device (a "Device") whenever you visit or interact with our Site. - Information contained in or relating to any communication that you send to us or sent through the Site, including the content of the communication and metadata associated with it.

How Do We Use Collected Information?

We and our service providers may use your information that is subject to this Privacy Policy:

- To send you electronic newsletters or to provide you with information such as special offers or promotional and marketing materials on behalf of us or third parties, including information about new products, services or upcoming events, as well as to verify your identity and to prevent fraud;
- To communicate with you about your transactions, such as to provide customer support;
- To send billing statements, service and collect amounts you owe;
- To customize your experience on the Site or to serve you with specific content or ads that are relevant to you;
- To improve the Site, our marketing and our Site offerings;
- For internal business purposes;
- For other purposes that are disclosed at the time you provide your information or otherwise set forth in this Privacy Policy; and

What about Cookies, Web Beacons and other Tracking Technologies?

The Companies use tracking technologies, such as Cookies and Web Beacons, on our Site to collect and store Usage Information whenever you visit or interact with the Service. A "Cookie" is a small file containing alphanumeric characters that stores information about the user or records the user's browsing activity. Cookies are stored on your Device's hard drive. A "Web Beacon" is an electronic image (1x1 .gif) located within a certain web page that allows the Site to record the simple actions of the user opening the page. Cookies, Web Beacons, and other tracking technologies (e.g., HTML5 and Flash local storage, embedded scripts, and e-tags/cache browsers) may be active on our Site. Your browser should allow you to manage tracking technologies. However, if your browser's settings are too restrictive you may not be able to use all of the features of this Site.

How About Interactions with Third-Party Services?
